# SCHOLARSHIP AGREEMENT

### KNOW ALL MEN BY THESE PRESENTS :

This Scholarship Agreement is entered into this \_\_\_\_\_ day of May/June 2001 by and between :

The Philippine Science High School-Bicol Region Campus (PSHS-BRC), a chartered science high school under the Department of Science and Technology (DOST), located along Goa, Camarines Sur represented in this agreement by its Director, Dr. GREGILDA S. PAN, hereinafter referred to as *PSH-Bicol Region Campus*;

#### WITNESSETH:

WHEREAS, pursuant to R.A. 3661, otherwise known as "An Act to Establish the Philippine Science High School" and R.A. 8496 or the "Philippine Science High School Act of 1997", the purpose of the PSHS shall be to offer on a free scholarship basis a secondary course with special emphasis on subjects pertaining to the sciences and mathematics with the end view of preparing its students for a science career;

| WHEREAS, after qualifying in two competitive examination and the recommendation of the Admissions Committee and approval of the Bo | -      |

NOW THEREFORE, for and in consideration of the foregoing premises and the conditions and stipulations hereinafter set forth, the parties hereto mutually agree and covenant unto each other, to wit:

#### I. Nature

The Philippine Science High School Scholarship is awarded to enable the scholar to pursue a secondary course with special emphasis in the sciences and mathematics to prepare him/her for a science or engineering career at the university level.

#### II. Duration of Scholarship

This Scholarship Award shall be for a duration of four years effective June 1, 2001, unless earlier terminated due to failure to comply with the terms and conditions of this scholarship agreement.

### III. Scholarship Privileges

The scholar-awardee shall be entitled to free tuition and free loan of available textbooks. He/She shall be entitled to the additional benefits that his/her scholarship category provides, subject to the availability of funds and government accounting/auditing rules and procedures.

### IV. Responsibilities of the PSHS Scholar

A. Academic Performance

The scholar-awardee shall maintain a year-level average of not lower than **2.50** and a cumulative average of not lower than **2.50** in science, mathematics, computer science and technology subjects. He/She shall neither have a failure in any academic subject nor a final character rating of **4** or "NEEDS IMPROVEMENT".

B. Conduct

The scholar-awardee shall behave in a manner befitting his/her status as a scholar and shall comply with all school rules and regulations as defined in the Code of Conduct/Student Handbook.

C. Report Cards

The scholar-awardee shall see to it that his/her report card is properly noted by his/her parent/guardian every quarter.

D. Guidance and Supervision

The scholar-awardee shall take all tests and inventories to establish data required for an effective school guidance and counseling program.

E. Change of Legal Guardian

The scholar-awardee shall report any change of legal guardian/representative and their respective residential addresses to the OFFICE OF THE REGISTRAR.

#### V. Penalties

A. Termination of Scholarship

This scholarship shall be terminated for failure of the scholarawardee to maintain the academic grade and character rating requirements, or for violation of any of the terms and conditions of this Agreement, or where the penalty imposed for the commission of a major offense as defined in the PSHS Code of Conduct/Student Handbook is termination of scholarship. The termination shall take effect fifteen days from receipt of written notice to the scholar-awardee.

B. Suspension, Temporary Withdrawal of Privilege

The PSHS shall impose on a scholar subject to disciplinary action, appropriate sanctions preliminary to termination of scholarship for the commission of a major offense as defined in the PSHS Code of Conduct/Student Handbook.

## VI. Scholarship Obligations

A. Completion of Secondary Course

The scholar-awardee is required to complete secondary course with emphasis in science and mathematics at PSHS-Bicol Region Campus. For willful abandonment of the scholarship, he/she shall be required to reimburse the money value (tuition and other registration fees) of his/her scholarship, based on rates to be determined by PSHS-Bicol Region Campus.

B. Pursuit of Course in Science and Technology

The scholar-awardee shall pursue a course in science and technology, falling under the specified needs of the manpower development of the Department of Science and Technology and the DOST Council, such as the Basic Sciences, Applied Sciences, Molecular Biology and Biochemistry, Biotechnology, and the like.

C. Change of Status Before Compliance with letter B Above

The scholar-awardee shall not take up residence on permanent basis in a country other than the Philippines until after compliance with the obligation stated in VI.B.

D. Membership in the PSHS Alumni Association

The scholar-awardee, after graduation from the PSHS shall apply for and pay membership dues with the PSHS Alumni Association.

He/She shall support alumni activities aimed at promoting the objectives and philosophy of the PSHS educational program.

### VII. Obligations of Parents/Guardian

- 1. Assume the civil liabilities that the said scholar may incur under the foregoing agreement in favor of the PSHS-Bicol Region Campus and other persons;
- 2. Shoulder the medical and other expenses in case of the sickness, disability or death of the aforementioned scholar;
- 3. Absolve the school of financial and legal responsibilities in case of accident or death arising from activities not officially sanctioned or supervised by the PSHS-Bicol Region Campus;
- 4. Provide other expenses of the scholar which are not specifically provided for in this agreement;
- 5. Help in the moral, spiritual and intellectual development of the aforementioned scholar;
- 6. Reimburse to the government the full cost of the scholarship in the event that the scholar willfully abandons the scholarship or fails to take up a science or science-related career at the university level. However, the latter may be subject to a waiver on a case-to-case basis.
